Please note that you DO NOT need an Invitation Letter from the Trade Fair Company, to apply for Schengen Visa to German Embassy/Consulate. This rule has changed since September 2013 and has been passed by the German Government.

For a Person travelling to the Trade fair as a Visitor, should submit the following information :

- 1) Visitor admission eTicket which is to be purchased Online.

Apart from the above, please contact the German Embassy/Consulate Region from where you will apply for Schengen Visa or visit their official website to find out what other documents you need to submit on a personal level as well.
